will be implementing a new option available to schools participating in the National School Lunch and School Breakfast Programs called the Community Eligibility Provision (CEP) for the 2020-2021 School Year.

What does this mean for you and your students who attend any school in the division?

Great news for you and your students! All enrolled students of any school in *Scott County Public Schools* will receive a healthy breakfast and lunch at **no charge** to your household each day of the 2020-2021 school year. Meals will be available for virtual learning days, as well as in-person instruction days.

CEP will be evaluated at the end of the school year to determine if it will continue into the future. It's important for all enrolled students to participate in both breakfast and lunch every day to make the program a success!
