



Wellness Policy 2017-2018

I. Policy Statement

Gate City Middle and Gate City High Schools support the health and well-being of the District's students by promoting nutrition and physical activity at all grade levels. In accordance with federal law, it is the policy of the Board to provide students access to healthy foods and beverages; provide opportunities for developmentally appropriate physical activity; provide nutrition education; and require that all meals served by the District meet or exceed the federal nutritional guidelines issued by the U.S. Department of Agriculture.

USDA is an equal opportunity provider, employer, and lender.

II. Wellness Policy Leadership

The designated official for oversight of the wellness policy is the School Nutrition Supervisor. The official shall convene the Wellness Committee and lead the review, updating and evaluation of policy.

Gate City Middle and Gate City High shall designate a site coordinator who shall ensure compliance with the policy.

III. School Wellness Committee

To assist in the creation of a healthy environment, the District shall establish a Wellness Committee that will provide ongoing review and evaluation of the Wellness Policy. The Committee shall meet no less than 3 times during the school year to implement, assess and review, and make recommendations for changes to the Wellness Policy. The Committee shall consist of a diverse group of stakeholders to participate in the development, implementation, periodic review and updating of the Wellness Policy.

IV. Goals

Gate City Middle and Gate City High Schools have established the following goals to promote student wellness.

A. Nutrition Education

- 1. Nutrition topics shall be integrated within the comprehensive health education curriculum taught at every grade (7-12)
- 2. The entire school environment, not just the classroom, shall be aligned with healthy school goals to positively influence a student's understanding, beliefs, and habits as they relate to good nutrition and regular physical exercise.
- 3. Nutrition education will incorporate helping children acquire skills for reading food labels and menu planning.
- 4. Nutrition education curriculum is aligned with state and federal learning objectives and standards.
- 5. Nutrition is integrated into the health education or core curricula (e.g., math, science, language arts).
- 6. Schools link nutrition education activities with the coordinated school health program.
- 7. Staff who provide health education, culinary arts, and nutrition/wellness classes will have appropriate training and/or licensure.
- 8. The level of student participation in the school breakfast and school lunch programs is appropriate.
- 9. Gate City Middle and Gate City High Schools are enrolled as Team Nutrition Schools, and they conduct nutrition education activities and promotions that involve parents, students, and the community.
- 10. Nutrition education instructional activities shall stress the appealing aspects of healthy eating and be participatory, developmentally appropriate, and enjoyable. The program shall engage families as partner in their children's education.
- 11. Gate City Middle incorporates Health/Nutrition classes during 7-9th grade PE classes.
- 12. Gate City High incorporates Health/Nutrition classes during 10-12th PE classes.
- 13. Gate City High offers Wellness Classes for 11th-12th grade students.

B. Physical Activity

Students are given opportunities for physical activity during the school day through physical education (PE) classes and the integration of physical activity into the academic curriculum where appropriate.

1. Students are given opportunities for physical activity through a range of before and/or after-school programs including, but not limited to, intramurals, interscholastic athletics, physical activity clubs and other after school programs.

- 2. Gate City Middle and Gate City High Schools encourage parents and guardians to support their children's participation in physical activity, to be physically active role models, and to include physical activity in family events.
- 3. Gate City Middle and Gate City High Schools provide training to enable staff to promote enjoyable, lifelong physical activity among students.
- 4. Gate City High School provides 11-12th grade students opportunities to participate in Advance PE classes and Health/Wellness classes.

C. Other School-based Activities

- 1. Fresh fruit/vegetable snacks are offered daily, when grants are available, to certain elementary schools that meet the criteria of 75% free & reduced lunches.
- 2. Grab-N- Go Breakfast is available in Gate City Middle and Gate City High to ensure every child has an opportunity to eat a nutritious breakfast.
- 3. Grab-N-Go Supper is available in Gate City Middle and Gate City High to ensure every student staying afterschool for any activity has an opportunity to eat a nutritious supper.
- 4. An adequate amount of time is allowed for students to eat meals in adequate lunchroom facilities.
- 5. All children who participate in subsidized food programs are able to obtain food in a non-stigmatizing manner.
- 6. Physical activities and/or nutrition services or programs designed to benefit staff health have been considered and, to the extent practical, implemented.
- 7. School staff are encouraged to model health eating behaviors.
- 8. The commonwealth of Virginia mandated screenings for students are performed within the guidelines set up by the Code of Virginia. Appropriate referrals are then completed for hearing, vision, and dental.
- 9. The Scott County Health Department, in conjunction with Lee County & V/ise County Health Departments, provide free dental screenings by a dental hygienist. 10. The Scott County Health Department offers Flu vaccines to all eligible students and staff members in the fall for those that are interested.
- 11. School Health Services cooperates with the Scott County Health Department in tracking communicable diseases, influenza and influenza like illnesses to monitor the health status of our students.
- 12. CPR is provided by school nurses for all 9th grade students.
- 13. Blood Borne Pathogens training is given to the staff on a yearly basis. CPR/1st Aide training is offered for those staff who are mandated by the state of Virginia to be certified in order to perform their job duties/skills
- 14. Vending machines in Gate City Middle and Gate City High Schools offer healthy snacks during breaks only. Vending machines are automatically set to turn off during meal times.

D. Nutrition Guidelines

- 1. Nutritional standards for the school breakfast and school lunch programs, a la carte items, and after school snacks meet or exceed state and federal standards.
- 2. All food and beverages sold and served outside the school meal program ("competitive" foods and beverages) shall, at a minimum, meet the standards established in the USDA's Nutrition Standards for all Foods Sold in Schools (Smart Snacks) rule.
- 3. The nutritional content of foods and beverages donated for class parties or other school events is considered.
- 4. Marketing: Schools will restrict food and beverage marketing to only those foods and beverages that meet the nutrition standards set forth by USDA's Nutrition Standards for All Foods Sold in Schools (Smart Snacks) rule, marketing includes brand names, trademarks, logos, or tags except when placed on a food or beverage product/container; displays, such as vending machine exteriors; corporate/brand names, logos, trademarks on cups, posters, school supplies, education materials, food service equipment, and school equipment (e.g. message boards, scoreboards, uniforms); advertisements in school publications/mailings; sponsorship of school activities, fundraisers, or sports teams; educational incentive programs such as contests or programs; and free samples or coupons displaying advertising of a product.
- 5. Outreach strategies to encourage families to reinforce and support healthy eating and physical activity are in place.
- 6. When drinking fountains are not present in the cafeteria, water cups/jugs are available.
- 7. Menus shall be posted on the district and school websites.
- 8. A list of nutritional values for daily food choices is updated and maintained by the school nurse and is available in the clinic.
- 8. Gate City Middle and Gate City High Schools allow up to 30 exempt fundraisers per school year. All other fundraisers sold during the school day must meet Smart Snacks nutritional standard. No restrictions are placed on the sale of food/beverage items sold outside of the school day.

E. Community Engagement

1. Gate City Middle and Gate City High Schools shall provide information on how the public can participate in the school wellness committee on an annual basis.

F. Monitoring and Evaluation

l. Gate City Middle and Gate City High Schools wellness policy shall be updated as needed based on evaluation results, District changes, emersion of new health science information/technology, and/or new federal or state guidance are issued.
